The bulk of our expenses came from the Pastoral Charge distribution. This year we were fortunate not to have to pay one month or \$6,200 of Pastoral Charge expenses. A full accounting of the Board of Management expenses is shown in Figure 2.

As for other achievements in 2019, we contributed \$4,404 to M&S and \$7,085.01 to our Building Fund.

As for the finances of the church, we had a positive net donation of \$5,311 in 2019. Given a 2018 previous Board of Management balance of \$20,450.26, we closed with a balance of \$25,762. Our expenses for the year were \$90,663, and our donations were \$95,975.

The **Cemetery Fund** is only used to receipt donations and is not the cemetery management account. The **Khalaf Fund** balance of \$579 will be fully distributed in early 2020 and closed, the **Paving Fund and Elevator Fund** are now at zero and are fully paid and will be closed. The **Revitalization Fund** was to establish to deploy new technology. Recent expenses include and iPad to broadcast live services. As a footnote,

the paving fund was established through the generosity of a very generous anonymous donor who specifically requested that the donation be made for paving only.





This year our United Church Investment Fund (permitted to be used only for the minister's living allowance portion of her salary) began with a value of \$184,620 and ended with a value of \$208,322 even after we withdrew \$10,000. See details below

Our total budget for the year 2020 is expected to be \$97,385, and our project deficit for the year is \$4,885.

Typically, 28% of our church budget is supported by PAR (~\$25,000), fundraisers support 27 %, Sunday offerings support 34 %, and our investment supports the other 11%. If, by example, our local offer increased by 9.1%, we would completely wipe out the 2020 projected deficit.
