Greg Reinhardt asked the group to review the 2022 Annual Reports. Sheila Kindred asked for the addition of Joyce Marks, who passed on August 31, 2022, to the Passage of Life for Parkhill United Church on page four of the report.

Douglas Garrison made a motion to approve all the 2022 reports except the financials. Crystal Gilkie seconded the motion. The motion was approved by all and carried. Pat Thomas pointed out there is no Sunday School report from 2022.

Our secretary, Liz Cann, asked that we acknowledge and thank Pat Thomas for her help in compiling the Annual Reporting. Thank you, Pat.,

Sheila Kindred discussed the Amalgamation report and explained that Parkhill United church property has not been sold yet. There has been work on closing up the church and all the possessions. There have been many charitable donations especially for Ukrainian families who have come to Canada. Sheila Kindred said she would keep us updated as things unfold with the selling of the property.

Sheila Kindred discussed the financial budget for Parkhill and explained that they had to draw from their investments last year to cover expenses and keep from going into debt.

Sheila Kindred made a motion to approve the financial report for Parkhill United. Church. Aronda Garrison seconded the motion. Everyone approved the motion, and it was carried.

Douglas Garrison discussed the financial report for St. James on page five of the report. He explained that the accounts and the M & S remittances would be changed over to St. James United. He said it was taking time for the changeover to be completed. Douglas Garrison made a motion to accept the 2022 financial report for St. James United Church. The motion was seconded by Aronda Garrison, approved by all, and carried.

An enthusiastic thank you was given by all to Douglas Garrison and Dylan Gray for their work on the budget and financial reports.

Greg Reinhardt passed a handout of the amended page twenty of the Financial Statement of St. James United. He reviewed the details of the statements and explained that there was a one time only, big donation to St. James United church last year. He also highlighted how much lower the power expenses for the year because we invested in heat pumps.

Greg Reinhardt said that current perspective for St. James United is in the positive with donations and expenses.

Greg Reinhardt made a motion to accept the 2022 financial report. The motion was seconded by Barb Reyno, approved by all and carried.

Greg Reinhardt spoke about the projected budget for 2023 and how the finances are reviewed every month. He spoke about the transition to the new consolidated St. James. Greg Reinhardt highlighted that we are very fortunate not to owe anything and that the investments are doing well.

Greg Reinhardt made a motion to accept the 2023 projected budget. The motion was seconded by Clyde Gray, approved by all, and carried.

Greg Reinhardt asked us to recognize all our volunteers, especially Barb Reyno and Aronda Garrison, for the successful suppers and the dinner theatre that brought in many donations.

Everyone thanked Greg Reinhardt for the important work keeping the finances organized.

Greg Reinhardt spoke about the procedure on the amalgamation process of Parkhill and St. James United churches. He explained the change that there are now only two existing bodies of management. Session and Board of Management overseeing the work of our amalgamated churches.

Greg Reinhardt asked we give a big thank you to the Search and Selection committee for their hard work, sometimes without much guidance. Thank you very much committee.

Pat Thomas said we usually speak about our visions and wishes for the next year but because we are receiving a new minister in May that we should wait on that.

Pat Thomas made a motion to have a congregational meeting by September 2023, with the new minister. The motion was seconded by Crystal Gilkie, agreed by all, and carried.

An enthusiastic thank you to Rev. Kathleen Anderson for everything and best wishes for the future.

An invitation to any Parkhill members to join the Board of Management committee by Douglas Garrison.

Douglas Garrison moved to adjourn the meeting.

6 Congregational Report

6.1 Parkhill United Church Board of Management Report 2023

Although the Parkhill congregation closed its doors on 31 December 2022, our Board continued to meet throughout 2023 to conduct the financial business of the church. Winter did not prove to be the best time to market our property. However, in preparation for finding a purchaser, we cleared the church and were happy to send to St James important and well-loved liturgical items, which included our cross, communion table, font, and creche tableau. It is very meaningful for those of us who have joined the St James community of faith that these items have found a new home at St James's.

During the year, we have worked closely with the Property Committee of the Bermuda and Nova Scotia Region and are grateful for their advice about what issues we needed to address. In July the Property Committee approved the Parkhill Board's recommendation to accept an offer to purchase the property for \$550,000. The new owners are a young family, who plan to use the property for their personal residential purposes.

The sale closed on 1 September 2023. Please see the PUC Treasurer's Report and the Interim Report on Selling the Church for further details about the sale. There will be a final Board of Management report in 2024.

6.2 Parkhill United Church Treasurer's Annual Report 2023

Parkhill United Church ended activities as a faith community on 31 December 2022 and its property was sold on 1 September 2023. In addition, the Parkhill congregation joined with its sister church, St James, Sambro on 1 January 2023. However, the Parkhill United Church still exists as a "preaching point" of the Sambro-Jollimore Pastural Charge until it is formally "closed." That will occur in 2024 when all the Church's assets are accounted for and disposed of to the satisfaction of the Bermuda-Nova Scotia Region of the United Church and the Charities Directorate of the Canada Revenue Agency. Meanwhile, this document records the finances of the Parkhill Church for 2023 in the same form as its past Annual Treasurer's reports. In addition, a second report below draws on the data in the Treasurer's Report to provide a convenient snapshot of the progress in selling and dispersing the Parkhill Church's assets through 2023 to 31 January 2024.

6.3 Parkhill and Beyond UCW Annual Report (PBUCW) 2023-2024

We all looked forward to coming to Church each week where the shared worship bonded us together. The UCW group played a vital role in the running of many Church activities which strengthened our spiritual fellowship and built strong bonds of friendship. Our group met once per month at the home of one of our members to conduct our meeting which began with the roll call. Each person responded by repeating a verse of Scripture. The Business Meeting was then called to order by Regine Maas, our Worship leader. Several topics on the agenda were discussed. Some special projects included participation in World Day of Prayer, Fundraising and contributions to various charities such as St Paul United Church Family Resource Centre, Phoenix House, M&S Fund, Lease at Parkhill United Church we had a vibrant UCW group of ladies whose faith, productivity and persistence helped to make the Church into a very welcoming place to meet and worship. Coin, Revd. Trevor Phillips Scholarship Fund and other worthy causes. Throughout the year volunteers decorated the Church to reflect the seasons of the Church Calendar such as, the Greening of the Church, Advent and Christmas Eve Services. The Annual Fund-Raising sales held in the summer on the Parkhill Church grounds were community events and people from the community supported us by purchasing items old and new and contributed funds towards Parkhill's budget.

With the adjournment of the Business Meeting, the Worship Service began. In an attitude of reverence, we joined in a responsive prayer followed by the reading of a Scripture passage relevant to the topic for discussion. Sometimes a story about the life and work of a person or group and their contributions to missionary work was explored during the discussion. The Service was interactive, and we had lively discussions in which each person felt free to express her views, the session ended with prayer. Later in the evening, we shared in a repast of tasty food and drink. These social interludes were joyful and stimulating, they strengthened our faith in the Lord and created strong friendships within our Church community. Parkhill Church has an amazing history extending over seventy years and many families with children were blessed to experience the guidance of wonderful Ministers. Several events took place in which the congregation interacted happily with the local community, and we deeply regret the demise of this wonderful Church Home which held so many special memories for us.

During 2020 the global COVID -19 pandemic had a negative impact on our Church at Parkhill. Mandated Government restrictions and closure lead to isolation and inability to share in regular congregational worship, this took its toll on our Church Community. Some individuals became victims of illness and death, others relocated for various reasons. The combined effect of these factors degraded our once vibrant Parkhill Church population and it fell below it carrying capacity. Financial and physical viability and low attendance became major questions for the Church Board. Could Parkhill Church survive as we once knew it? After many meetings and consultations, the decision was made to close the Church, sell the property, and amalgamate with St James United Church in Sambro.

Our end of year Outing took place in the summer to remind ourselves of the joy we once experienced when we went on meaningful outings in past years. A group of our Church members both male and female drove many miles to visit the Interpretive Centre- Marine Museum of the Atlantic at Terence Bay. It was a very educational tour in which we viewed artifacts from the SS Atlantic Steamship, sister ship to the Titanic which sank off the coast of Nova Scotia in 1873. After the tour we enjoyed a wonderful picnic on the boardwalk near the seaside on a beautiful bright and sunny day. Being reunited was a special and joyous occasion.

Reflection:

You may ask what have we done since that dreadful day when we were forced to detach our emotions from our favourite Church in the Jollimore Village?. As a direct consequence of COVID 19 restrictions there was no World Day of Prayer gathering held. We regret missing this very meaningful annual Service which usually included members of several Churches in Halifax. At these gatherings, we were encouraged to support and contribute to missionary work worldwide. After much prayer, it became evident that we needed to form a focus group to recapture what we lost in fellowship at our Parkhill UCW. The First Meeting to explore establishing a new UCW group was held at the home of Sheila Kindred on March 23.2023. We selected this name: Parkhill and Beyond United Church Women (**PBUCW**). It felt good to be together again. Although the initial group is small, we hope to expand and include members from Sambro.

The second meeting of PBUCW was held at the home of Marilyn Pierce on May 23rd. The Business Meeting preceded the Worship Service. We explored the history of the life and works of John Newton and learned of the significance of the dearly loved Hymn "Amazing Grace" he wrote. Marilyn led the music at the piano and we enjoyed singing many of his other Hymns. The third PBUCW meeting was held at the home of Olive Phillips. We were blessed with the presence of our new Minister Revd. Sean Hitchcock. The Scripture reading and the Topic chosen focused on exploring the Power of the Holy Spirit in our daily lives in our present world. The discussion was powerful, and everyone joined in and readily shared their spiritual experiences. We welcomed the opportunity to interact with our new Minister over a cup of tea.

We are off to a good start with the arrival of Tanya, a new member who knew all about the history of the Marine Museum at Terence Bay and she regaled us with many more interesting stories. We look forward to seasons of growth in the years ahead as our membership grows.

To whom it may concern,

As per St. James Board of Management Meeting of February 2023 it has been decided to close the current Cemetery Fund Account at the Royal Bank of Canada, Herring Cove Road, Halifax, Nova Scotia Account # 06113-0011266 due to the incorporation of a Print Statement Fee of \$2.25. This fee occurs, for the most part, on a monthly basis should there be a transaction applied to the account. There are very minimal operational transactions occurring, so the fee is primarily being applied when a minuscule amount of interest is deposited to the account.

This account which has been open for over 45 years and was converted by RBC from a passbook account to a Personal Savings Account on November 15, 2018. There were assurances made by RBC at this time there would be no additional fees.

However, in August 2022 the Print Statement Fee began being applied anytime a transaction occurred on the account. There were multiple attempts to have the fee eliminated but without success.

Moving forward, the Cemetery Fund will be managed through the St. James United Church banking.

6.11 St. James Financial Narrative & Statement 2023

Before we review the financials for 2023, we would like to thank each one of you for a successful unique year like no other. It was the first year that Parkhill United amalgamated with St James United; it was a year that rejuvenated St James's and its future in a way that laid the foundation for spiritual growth, community engagement, and stewardship for years to come. If the opening paragraph sounds exciting - it should. Did we win a million dollars – no – did we have a surplus for the year - yes. Have we set a successful path forward – absolutely. Does it mean smooth sailing - not exactly? But with a constant finger on the pulse of the church and community, we can be a partnership like no other. The church's future will still require hard work, community involvement, and financial and spiritual support.


So, what did 2023 look like? Before we get into the details of the financial report it is important to understand that in 2023, we had the largest transfer to our investment and church in the life of the church. As part of the amalgamation of Parkhill with St James the congregation of Parkhill generously transferred \$350,000 of the sale of their church to St. James. This transaction will support the church annually like an annuity distributed annually, very similar to the approach that was used with the sale of the manse almost 15 years ago. As a point of reference, the manse was sold for \$158,000 and we have been taking on average \$15,000 a year and the current balance of that investment is \$281,326.

Back to the financials of 2023, we ended the year with a surplus of **\$2,055.45** and

a Board of Management Balance of \$26,267.61.

To start we brought in a total of \$116,608 in donations of which \$40,755 came in the form of local (Sunday offering plate), \$35,718 came in the form of Suppers and Dinner Theatre and was mentioned previously we used \$20,000 from the sale of the Parkhill church. Other donations of \$10,199 came from funeral receptions, Pastoral charge account transfers, and other misc. donations.


The diagram below gives you a proportional view of the donations with 31% being Dinner theatre/ Supper, 43% being local Funds and 17% being the investment or Amalgamation transfer.

Our expenses for the year were **\$114,553.22**. The largest proportional

expense was the minister's prorated salary of \$61,808, followed by \$15,785 for employee benefits. Other expenses in order included the organist team at \$8,640; Nova Scotia Power at \$5,852; our contribution to the United Church expense at \$4,573 and finally miscellaneous expenses of \$4,075 (Website registration, church software, virus protection, Christmas gifts, propane, heat pump cleaning and one license just to mention a few)

6.12 St. James United Budget for 2024

Included in the financial report are the budget for 2024, the budget for 2023, actuals for 2023, and actuals for 2022. As a point of reference, the actuals for 2022 do not reflect the pastoral charge expenses which is one of the key reasons for increases in certain categories. (i.e. minister's salary, etc.).

As we look ahead to the 2024 budget you can see that the figures are based on 2023 actuals or updated information based on projection. Highlights of the 2024 budget include a need to take more from the investment given the projected fundraisers and local donations. A Disney year would be an increase in PAR and local donations as well as increased success in our fundraising. Each would impact or reduce the need to take from the investment.

As a footnote please also take note that 2023 brought with it about \$10,000 in other donations which are situational and not expected for 2024.
